



THE SECTION 106 ESSENTIALS REGISTRATION CONFIRMATION AND COURSE INFORMATION

*An in-depth look at historic preservation responsibilities
under the National Historic Preservation Act*

“The Section 106 Essentials” course is on Monday, April 3, and Tuesday, April 4, 2006. Please review the following information before traveling to Las Vegas, NV.

Accommodations:

The course is being held at the **Westin Casuarina Las Vegas Hotel, Casino & Spa**. The facility address is: **160 E. Flamingo Road, Las Vegas, Nevada, 89109, Tel: (702) 836-5900, Fax: (702) 836-9776**. A limited block of rooms has been secured for attendees for Sunday, Monday and Tuesday nights, April 2 – 4, 2006 for the rate of **\$189.000** (plus 9 % tax) per night.

Reservations must be made no later than **Friday, March 3, 2006**. Reservations made after that date will be accepted on a space available basis at whatever rate is available at the time of the reservation. Check in is at 4:00 pm and checkout is at 11:00 am. **To reserve your room**, call the hotel directly at 866-837-4215 and say they are with Advisory Council on Historic Preservation. Please make your reservations as soon as possible as rooms are limited and will most likely sell out.



Travel to Westin Casuarina:

McCarran Airport (www.mccarran.com) is the main airport serving Las Vegas and Clark County. It is located 1 mile (1.6 km.) from the Strip, 3.5 miles (5.6 km.) from the Convention Center and 5 miles (8 km.) from Downtown Las Vegas. The Las Vegas Airport is ranked among the 10 busiest airports in the world based on the amount of passenger activity, serving over 40 air carriers. With over 950 flights arriving and departing daily, McCarran International Airport offers direct flights to more than 100 U.S. cities. For other ground transportation information, go to (www.mccarran.com/03_index.asp). Note: Taxicabs are available outside on the east side of [baggage claim](#), outside door exits 1-5. Airport personnel are available on the taxi curb to assist passengers. Taxis will not accept credit card payments. There is a \$1.20 charge on all fares originating at the airport. The maximum number of passengers allowed in any taxi is five (5), including infants and children.

Driving Directions:

- From East - take 95 North to I-15 South. Take the Flamingo East Exit. Go straight across Las Vegas "Strip" and the hotel is located one block past on the left.
- From McCarran International Airport - Take Swenson north to Flamingo and turn left. Proceed for two blocks. The hotel is located on the right.
- From North - Take Interstate 15 South to the Flamingo East Exit. Go straight across the Las Vegas "Strip" and the hotel is located one block past on the left.
- From West - Take 95 North to I-15 South. Take the Flamingo East Exit. Go straight across Las Vegas "Strip" and the hotel is located one block past on the left.
- From South - Take I-15 North to the Flamingo East Exit. Go straight across the Las Vegas "Strip" and the hotel is located one block past on the left.



Parking:

There is free-self parking for patrons.

Registration:

Registration will be located at the foyer of the meeting room (TBA) and will be open 8:00 – 8:30 am on Monday, April 3, 2006. You must stop by the registration desk to pick up your course notebook and other course materials.

Schedule:

The Section 106 Essentials course runs from 8:30 am – approximately 4:30 pm each day. Short breaks will be given in the morning and afternoon. There will be a break for lunch, which is on your own.

Meals:

Light morning fare will be provided each morning along with an afternoon break each day. The cost of these food functions is included in the registration fee. All other meals are on your own.

Attire for Training Course:

Attire for the course is casual. Also, please keep in mind that hotel meeting rooms may be cool, so plan to bring a sweater or jacket.

Cancellations:

If made at least 14 days before the start of the course, registrants who cancel will receive a full refund minus a 15% processing fee. No refunds will be given for cancellations made fewer than 14 days before the start of the course; however, substitutions may be made at no cost up until three days before the course begins. All cancellations must be made in writing.
