The New Bedford Historical Society works to preserve and celebrate the heritage of African Americans, Cape Verdeans, Native Americans, West Indians and other people of color in New Bedford, Mass. Volunteers are the backbone of the group, and the Preserve America Steward designation recognizes their efforts to restore and interpret the Nathan and Mary Johnson House, an Underground Railroad site. # Familiar Faces Emerge at Secretary's Award Ceremony

When Secretary of the Interior Ken Salazar decided to use the ACHP quarterly business meeting March 1 for his Historic Preservation Award presentation, one of the honorees turned out to be a longstanding friend of the Preserve America Community (PAC) program.



Michelle Pierce, Lake City, Colo., received the Secretary's most recent award that is presented annually to a person who has made outstanding contributions to the National Park Service's Certified Local Government (CLG) program. When the ACHP heard Pierce was receiving the award both she and Lake City sounded familiar to ACHP staff members. Sure enough, Pierce had nominated Lake City to be a PAC early in the program's history.

The Secretary of the Interior's Historic Preservation Awards program was established relatively recently. Yet, of the first three CLG recipients, two have been PACs. William Morgan, of Muncie, Ind., was given the award in 2011. There also have been three years of awards presented to an individual serving as a Tribal Historic Preservation Officer (THPO). One of the former recipients, Kelly Jackson, is THPO for the Lac du Flambeau Band of Lake Superior Chippewa Indians, Wisc., whose tribe is a designated PAC.

It will be interesting to see if the Secretary's Award trend holds with PACs rising to the top of the recognition pyramid in years to come. Congratulations to Pierce, Jackson, Morgan and to Lake City, the Lac du Flambeau Band and Muncie for their outstanding preservation accomplishments.

### Preserve America Community Dorchester County Celebrates Harriet Tubman

One of the first designated Preserve America Communities in the United States, located on Maryland's Eastern Shore, is recognizing the centennial of the death of well-known African American abolitionist and Underground Railroad leader Harriet Tubman throughout 2013. Tubman was born into slavery in Dorchester County around 1822. On March 9, 2013, Maryland Gov. Martin O'Malley -along with several hundred national, state and local supporters broke ground for the 17-acre Harriet Tubman Underground Railroad State Park and Visitor Center,



commemorating her life and legacy. The park is projected to open in 2015. The 125-mile Harriet Tubman Underground Railroad Byway traverses Dorchester as well as adjoining Caroline County. Read more information.

#### **Hurricane Sandy Recovery Funding**

On Jan. 28, the U.S. Senate passed H.R. 152, a package of measures aimed at assisting victims of Hurricane Sandy in the Mid-Atlantic and Northeast. The President signed the bill into law the next day, since the House had passed the measure earlier. Included in the bill was \$50 million in grants from the Historic Preservation Fund for states and

tribes to pay for historic resource repair and rehabilitation projects, and such grants will not require a non-federal match. A portion of the money may also be used by the states to defray the costs of National Historic Preservation Act Section 106 compliance activities and program administration.

Several hard-hit areas have been featured in widespread news reports, including the New York City area, the New Jersey shore, and eastern Long Island. We are also aware of a number of Preserve America Communities that were affected by the storm up and down the coast, such as Lewes, Del., Wall Township, N.J., New London, Conn., Newport, R.I., and Falmouth, Mass. Some areas had downed trees, power outages, flooding and beach erosion; others more extensive structural damage. All affected communities and states are continuing their property assessments and planning for repair and rehabilitation work over the widely affected storm area.

### Come to Indianapolis!

The ACHP has proposed an affiliate session for the National Trust's annual Preservation Conference in Indianapolis, Ind., Oct. 29-Nov. 2, 2013. The theme of the conference is "Preservation at the Crossroads," and the title of the proposed session is "Historic Communities and



Tourism: How Do We Connect the Dots?," in partial recognition of the 10th anniversary of the Preserve America program. The session would be a two-hour forum similar to what the ACHP has been sponsoring for the last several years.
