“The Section 106 Agreement Seminar” will be on Wednesday, April 8, 2020.

**Course Location and Accommodations:** The course is taking place at [Wigwam Arizona](#), 300 Wigwam Boulevard, Litchfield Park, AZ 85340. A block of rooms has been secured for attendees for Monday - Wednesday, April 6-8 at the government rate of \$146 for a single occupancy plus applicable state and local taxes. When making your reservations, please indicate that the Resort Charge that applies to all guest rooms, **has been waived at \$30 per room, per night**.

Due date for reservations is **Monday, March 9, 2020**. Reservations made after that date will be accepted on a space available basis at whatever rate is available at the time of the reservation.

**Individual Cancellation:** You will be charged one night room and tax, if you do not cancel seven (7) days or less prior to arrival.

## **Transportation:**

### **Airport & Shuttle Information:**

25 minutes/20 miles from Phoenix Sky Harbor International Airport.

Shuttle service is not provided by the hotel directly, but there are public shuttle services available. Transportation options available would be the Super Shuttle which you can catch just outside of baggage claim. It is approximately \$30 per person. A taxi would be around \$70.

**Hotel Shuttle Info:** The hotel offers complimentary shuttle service to and from the Tanger Outlets at Westgate every Thursday through Sunday from 10 a.m.–6 p.m. Pick up at the resort is at the Wigwam front Drive. The shuttle will also service points within a five-mile radius from the resort. All reservations for the shuttle can be made directly with the Bell Desk. The Wigwam shuttle seats 14.

**Registration:** Registration will be located outside the conference room on Wednesday, April 8 at 8 a.m. Plan to stop by the registration desk to check in and to pick up your course notebook and other course materials.

**The Section 106 Agreement Seminar** runs from 8:30 a.m. to approximately 4:30 p.m. Short breaks will be given in the morning and afternoon with a longer break for lunch.

**Meals:** Light morning fare and an afternoon snack are provided. The cost of this food is included in your registration fee. All other meals are on your own.

**Attire for Training Course:** Attire for the course is casual. Also, please keep in mind that hotel meeting rooms tend to be cool, so plan to bring a sweater or jacket.
