Course Location and Accommodations: The course is taking place at <u>The Century House</u>, 997 New Loudon Rd., Latham, NY, 12110. A block of rooms has been secured for attendees for Monday – Thursday, July 13-16 at the government rate of \$113 for a single occupancy plus applicable state and local taxes. Individuals can make reservations by calling the hotel's toll free Reservation Line, (518) 785-0931 and identify themselves as members of the ACHP-Section 106 group.

Due date for reservations is **Friday**, **July 3**. Reservations made after that date will be accepted on a space available basis at whatever rate is available at the time of the reservation.

Hotel and Local Information: The Century House established in 1949 is a unique event venue, hotel, and restaurant in Latham, NY. It was in 1949 that James and Dorothy O'Hearn purchased the more than 100-year-old house, and The Century House Restaurant was established. Very quickly the O'Hearns gained a reputation for their hospitality, living in the upstairs of the farmhouse, and serving their guests in their own living and dining rooms. Today these are our North and Federal dining rooms. Much has changed since the humble beginnings of The Century House. The Century House including Ballrooms added in 1984 construction began on what would become The Century House Hotel, designed to reflect the traditional Federal-style that was our beginning.

Transportation:

The Century House hotel is located six miles from the Albany International Airport. The hotel provides free airport transportation between 8 a.m.-9 p.m. EST.

Driving Directions:

From North and South: Take I-87 (Adirondack Northway) to exit 7. Follow signs to Route 9 Latham. Turn right at light. Take Route 9 North. Hotel is one mile on right. From East and West: Take I-90 (New York Thruway) exit 24 to I-87 (Adirondack Northway) exit 7. Follow signs for Route 9 North. Hotel is one mile on right.

Registration: Registration will be located outside the conference room on Wednesday, July 15 at 8 a.m. Plan to stop by the registration desk to check in and to pick up your course notebook and other course materials.

The Section 106 Agreements Seminar runs from 8:30 a.m. to approximately 4:30 p.m. Short breaks will be given in the morning and afternoon with a longer break for lunch.
