

# Section 106 Agreements Seminar: St. Louis, MO – June 24, 2020

“The Section 106 Agreements Seminar” will be Wednesday, June 24, 2020.

**Course Location and Accommodations:** The course is taking place at [The Westin St. Louis](#), 811 Spruce Street, St. Louis, MO, 63102, Phone: 314-621-2000. A block of rooms has been secured for attendees for Monday – Wednesday, June 22 - 24 at the government rate of \$135 for a single occupancy plus applicable state and local taxes. Individuals can make reservations by calling 314-552-5806 or 1-800-WESTIN-1 (1-800-937-8461) and identify themselves as members of the Advisory Council on Historic Preservation (ACHP) Section or [Book your room for Advisory Council on Historic Preservation - ACHP](#). Cancellations made within 48 hours of arrival date will result in one night’s room and tax penalty.

Due date for reservations is **Friday, May 22, 2020**. Reservations made after that date will be accepted on a space available basis at whatever rate is available at the time of the reservation.

**Hotel and Local Information:** The Westin St. Louis is at the heart of St. Louis and all it has to offer. Positioned in historic Cupples Station, Westin is just steps to the Federal Courthouse, Ballpark Village, Busch Stadium, and the Gateway Arch. Located within the business hub of downtown St. Louis, Westin is situated just blocks from Enterprise Center, America’s Center (Convention Center), Edward Jones Dome, and Washington Avenue. Explore the city’s many attractions and neighborhoods, easily accessed via the MetroLink light rail system with a stop just outside the hotel door.

**Driving directions:** From the airport take I-70 E toward St. Louis. Merge onto 170 S via exit 238A toward Clayton. Follow for 7 miles and merge onto I-64 E/US-40 E via LEFT exit towards St. Louis. Follow for 8 miles and take the 11th St exit, EXIT 39B, on the left toward Stadium. Turn right onto Spruce.

## **Parking:**

- On-site parking, fee: 30 USD daily
- Valet parking, fee: 40 USD daily
- Bus parking available: \$100 per day per bus

**Registration:** Registration will be located outside the conference room on Wednesday, June 24 at 8 a.m. Plan to stop by the registration desk to check in and to pick up your course notebook and other course materials.

**The Section 106 Agreements Seminar** runs from 8:30 a.m. to approximately 4:30 p.m. Short breaks will be given in the morning and afternoon with a longer break for lunch.

**Meals:** Light morning fare and an afternoon snack are provided. The cost of this food is included in your registration fee. All other meals are on your own.
