WHEREAS, the Agreement was executed on April 19, 2017; and

WHEREAS, the Agreement was amended on October 30, 2018; and

WHEREAS, the Agreement, as amended, will expire on January 1, 2020 in accordance with Stipulation XIII; and

WHEREAS, funding challenges have resulted in a delay to the stipulated timeframes and the signatories have agreed to extend the duration of the agreement to allow sufficient time to reevaluate the timeframes of the stipulations and consult to consider an additional amendment that accounts for the adjusted timeframes; and

NOW, THEREFORE, in accordance with Stipulation X of the Agreement, VAWW, DAHP, ACHP, and CTUIR agree to amend the Agreement as follows:

1. Amend Stipulation XIII so it reads as follows:

XIII. Effective End Date

This Agreement will continue in full force and effect until April 19, 2023. At any time in the 6-month period prior to this date, VAWW may request in writing that the signatories review the Undertaking and consider an extension or modification of this Agreement. No extension or modification will be effective unless all signatories to the Agreement have agreed to it in writing.

All remaining stipulations remain in full force and effect.
