# FIRST AMENDMENT TO PROTOTYPE PROGAMMATIC AGREEMENT BETWEEN THE US DEPARTMENT OF AGRICULTURE, NEW JERSEY NATURAL RESOURCES CONSERVATION SERVICE STATE OFFICE, NEW JERSEY STATE HISTORIC PRESERVATION OFFICER, REGARDING CONSERVATION ASSISTANCE

**WHEREAS**, the New Jersey Prototype Programmatic Agreement (PPA) was executed on April 28th, 2016;

**WHEREAS**, the parties desire to amend the New Jersey PPA and have consulted pursuant to its terms;

**WHEREAS**, Stipulation XII of the PPA provides that the PPA shall be in effect for five (5) years from the date of execution, which is the date it was signed on April 28<sup>th</sup>, 2016

**WHEREAS**, Stipulation XIII, further provides that before the 5-year period lapses, the Signatories may amend the content of the PPA, which may include extension of the duration of the PPA, which is April 28th, 2021;

**WHEREAS**, the Natural Resources Conservation Service (NRCS) proposed, and the New Jersey State Historic Preservation Office (SHPO) have agreed, the PPA should be amended to extend the duration to allow completion of the stipulations to allow additional time for consultation between Signatories over existing agreement stipulations;

**WHEREAS**, the New Jersey NRCS will send a copy of this executed agreement to the Advisory Council on Historic Preservation and the NRCS Federal Preservation Officer;

**NOW THEREFORE**, in accordance with Stipulation XIII of the PPA, the New Jersey NRCS and the SHPO agree to amend the New Jersey PPA as follows:

1. Amend Stipulation XII so that it reads as follows:

This State-based Prototype Agreement will be in effect for ten (10) years from the date of execution (April 28th, 2016) unless amended or terminated pursuant to Stipulation XIII.
