WHEREAS, an extension of the duration of the Programmatic Agreement is necessary to allow sufficient time for consultation on a revised Master Plan and an implementation phasing schedule. It is anticipated that the revised Master Plan and schedule will be documented in another amendment to the Programmatic Agreement.

NOW, THEREFORE, in accordance with Stipulations VII, the Signatories agree to extend the duration of the Programmatic Agreement through December 31, 2021.
