Enter your arrival date and departure date, click on "More Options" and then click on "Add special rate codes." In the "Group code" field, enter your group code, which is **ACH**. The group information will pull up and you will continue the reservation process.

## **CUTOFF DATE**

The cutoff date is **Monday May 12, 2025**. Reservations must be made prior to the cutoff date and/or before the block is full, whichever comes first, in order to guarantee availability of the room block and discounted group rate that was contracted. Reservations made after the cutoff date will be accommodated based on availability at the best available rate.

**Hotel and Local Information:** Holiday Inn & Suites Nashville Downtown is a prime location near Broadway, which gives you easy access to Nashville's top attractions. Just steps from world-famous honky-tonks, Bridgestone Arena, Nissan Stadium, and the Ryman Auditorium, you'll be perfectly positioned to explore the best of Music City.

**Transportation:** The Nashville International Airport (BNA), (<u>Visit BNA airport website</u>) is approximately 10 minutes form the hotel. The hotel does not provide shuttle service; an estimated taxi fare is \$25 (one way).

**Parking:** On-site parking, fee \$53 daily. Valet parking, fee: \$66 daily.

**Registration:** Registration will be located in the **Cumberland Ballroom** on Wednesday, June 11 at 8 a.m. Plan to stop by the registration desk to check in and to pick up your course notebook and other course materials.

**Schedule:** *The Section 106 Essentials Training* runs from 8:30 a.m. to approximately 4:30 p.m. Short breaks will be given in the morning and afternoon with a longer break for lunch.

**Meals:** Light morning fare and an afternoon snack are provided each day. The cost of this food is included in your registration fee. All other meals are on your own.

Attire for Training Course: Attire for the course is casual. Also, please keep in mind that hotel meeting rooms tend to be cool, so plan to bring a sweater or jacket.

**Cancellations:** Registrants who cancel at least 14 days prior to the start of the course will receive a full refund minus a 15 percent processing fee. No refunds will be given for cancellations made fewer than 14 days before the start of the course; however, substitutions may be made at no cost up until three days before the course begins. All cancellations must be made in writing.
