WHEREAS, the *Memorandum of Agreement among the U.S. Department of Veterans Affairs, the Veterans Affairs Maryland Health Care System, the Perry Point Veterans Affairs Medical Center; the Maryland State Historic Preservation Officer; and the Advisory Council on Historic Preservation regarding the Replacement Community Living Center Project at the Perry Point Veterans Affairs Medical Center, Perryville, MD* (MOA) was executed October 31, 2014, and pursuant to Stipulation VI was stipulated to be in effect until October 31, 2021; and

WHEREAS, the MOA was amended on October 29, 2021, pursuant to Stipulation XI to extend the duration of the MOA for fourteen (14) years to remain in effect until October 29, 2035; and

WHEREAS, the Perry Point Veterans Affairs Medical Center (VAMC) has identified a need to terminate the MOA due to changes in the scope of work for the undertaking, including the change in location of the proposed new Community Living Center building on the VAMC campus so that the new building's construction will no longer require the demolition of Building 9H; and

WHEREAS, the VAMC will initiate consultation on the construction of the proposed new Community Living Center based on the updated scope of work pursuant to 36 CFR Part 800, the regulations implementing Section 106 of the National Historic Preservation Act (54 U.S.C. § 306108); and

WHEREAS, the VAMC has determined that the demolition of building 9H at the VAMC is still necessary and will initiate consultation on this separate undertaking pursuant to 36 CFR Part 800, the regulations implementing Section 106 of the National Historic Preservation Act (54 U.S.C. § 306108); and

WHEREAS, the signatories have determined that it is appropriate to amend the duration (Stipulation VI) of the MOA so that the MOA expires upon execution of this second amendment pursuant to Stipulation XI; and

NOW, THEREFORE, in accordance with Stipulation XI. of the MOA, the VAMC, SHPO, and the ACHP agree to amend the MOA as follows:

Amend stipulation VI. DURATION so it reads as follows:

VI. DURATION

This MOA will expire upon execution of this amendment.
